schedule below.

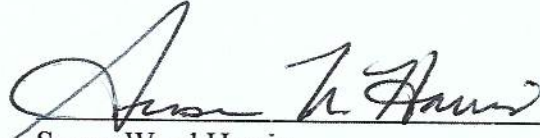
