
1 for a 30-day extension with the Court.

4 **28, 2025.**

6 **IT IS FURTHER ORDERED** extending the deadline for the parties and prepare
7 a Joint Status Report, including any information and input from ADWR. The report shall
8 be jointly filed by **April 18, 2025**, and include anticipated completion dates for any
9 additional research or resolution.

11 **IT IS FURTHER ORDERED** setting a Status Conference on **Thursday, April**
12 **24, 2025, at 10:00 am** before Special Water Master Sherri Zendri. The status conference
13 will be held using the Court Connect program. Instructions for Court Connect are

Joy Abrams is requesting a 60 day extension re: filing all SOC's and needs more time due to health issues to understand the details on this adjudication of her water rights on her land .

I am writing on behalf of my mom Joy Abrams who has been ill and has not been able to obtain enough information on filing all SOC's needed to protect her property rights (SoC for irrigation , surface rights , ground water) etc . We did send in a stock pond SOC however need more info if other forms need to be filed to protect value of her property and use for wildlife etc , irrigation in future .etc on her land .

My mom just yesterday spoke to Jennifer Wendell Attorney for Peterson and we are gathering information on their requests : water usage , volume , frequency , how many gallons taken from my moms pond per day etc , total volume of water in the pond in order to make best decision for my mom. We have not received the details and are not clear on what this will look like yet . We would need a contract and time to review the contract as well . My mom was not clear on next steps forward even after speaking to Atty Jennifer Wendell and I hope to gain more insight later this week speaking to Atty Wendell.

As you know water rights are a specialty area and we need more information to make best informed decisions for Joy Abrams and other parties .
