25 On January 27, 2017, the Arizona Department of Water Resources ("ADWR") filed a
26 Demonstration Project Report entitled "*De Minimis* Assessment & Cone of Depression Test
27 Methodology" for the San Pedro River Watershed (the "Report"). The Report is the culmination

1 of approximately two years of work that has been the subject of a series of progress reports to
2 which various parties have filed comments, objections and propounded further questions. The
3 parties may file objections and comments concerning that portion of the Report that describes the
4 Cone of Depression Test Methodology. A status hearing will be held to schedule proceedings
5 necessary to resolve issues with respect to the Cone of Depression Test Methodology.
