shown,

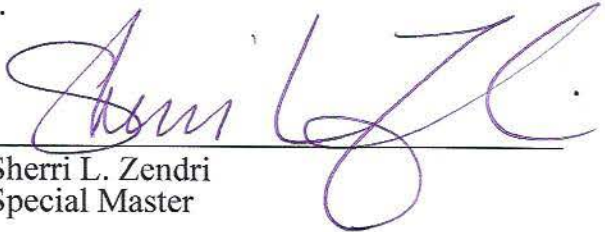

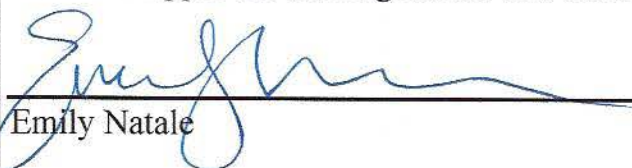
