10:00 a.m. This is the time set for a Status Conference to receive an update from the Baeurlen family regarding the basis of right and their progress with ADWR before Special Water Master Sherri Zendri.

Caleb Barajas informs the Court that he has submitted a Statement of Claimant with documentation of the new well drill. Based on his research, he doesn't believe his new well is pumping subflow.

Laura Baeurlen indicates that they will be moving forward with their application for a surface water permit and it's being processed with ADWR.

Nancy Luyten states that she missed the January hearing but did attend the meeting with ADWR. The Court will include additional contact numbers as a "LATER" in today's Minute Entry so Ms. Luyten may contact ADWR with any questions.

The Court addresses the parties regarding the purpose of this proceeding.

Discussion is held regarding the process for Mr. Barajas to challenge that he is pumping subflow. The Court will include a contact number for the Special Master's judicial assistant so Mr. Barajas can obtain the documentation.
