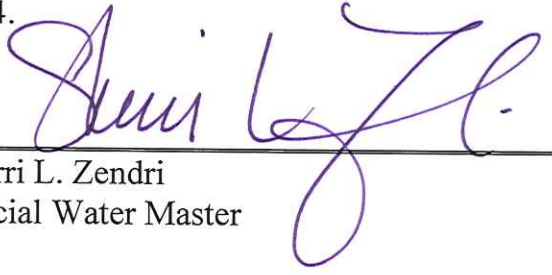

27 Consideration filed July 17, 2024. It is recognized the oral arguments were scheduled
28 unilaterally and with short notice. However, the San Carlos Apache Tribe is a nominal

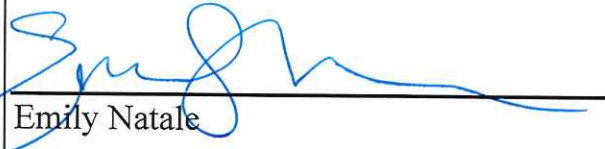
1 party to these oral arguments and considering the overall schedules of these trials,
