24 This case involves claims for water rights for domestic and irrigation uses in section 28
25 T18S R21E. Santiago Garcia filed Statement of Claimant 39-5470 for the claimed water uses.
26 The Arizona Department of Water Resources public records do not include an assignment of the
27 Statement of Claimant.

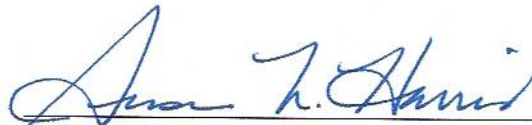
1 The Arizona Department of Water Resources investigated the claims and submitted its
2 results in Watershed File Report 112-17-DCA-018 ("WFR"), which was published in the Final
3 San Pedro River Watershed Hydrographic Survey Report (1991). The WFR listed one well as
4 the source of water. A copy of the WFR is attached as Attachment A. The purpose of this case
5 is to resolve the four objections made to the WFR. The Objectors are included in Attachment B.

7 According to the Cochise County Assessor, the property included in the WFR consists of
8 tax parcel no. 121-35-002. It lists Juan R and Lisa Gongora as the current owners of the property.
9 By a filing dated June 1, 2022, the St. David Irrigation District represented that the well included
10 in the WFR is registered to the St. David Irrigation District and that this case should be
11 consolidated with *In re St. David Irrigation District*.
