Court reporter, Hilda Lopez, is present as well as a record of the proceedings being made by CD/videotape.

The Court provides clarification to the Intervenor's that the forthcoming evidentiary hearing is for the narrow purpose of considering SRP's request for provisional relief against Kovacovich Investment Limited Partnership, Wiertzema Family Trust, and NBJ Ranch Limited Partnership and that there will be no final "subflow determination" made.

Discussion is held with Mr. Staudenmaier and Mrs. Winkler with respect to the parties' pretrial statement, specifically as it relates to the Intervenor's anticipated participation in the evidentiary hearing. The Court is advised and approves of the Intervenor's limited participation in the hearing.

Mr. Lewis, counsel for SRP, affirms that the purpose of its request for preliminary injunction is to enforce the existing injunctions entered by the Yavapai County Superior Court.

Mr. Douglas E. Brown and Mr. Lewis present argument to the Court with respect to NBJ Ranch Limited Partnership's Motion for Summary Judgment and the joinders thereto.

Based upon the arguments presented,

IT IS ORDERED denying NBJ Ranch Limited Partnership's Motion for Summary Judgment and the joinders thereto.

Mr. Mabery and Mr. Lewis present argument to the Court with respect to Kovacovich Investment Limited Partnership and Wiertzema Family Trust's Motion to Dismiss or in the Alternative Motion for Summary Judgment.

After considering the arguments of counsel, the Court finds that the only relevant factor for the purpose of the forthcoming evidentiary hearing is whether or not the Kovacovich Investment Limited Partnership and Wiertzema Family Trust are in violation of the injunctive relief originally ordered by the Yavapai County Superior Court. For that reason,

IT IS ORDERED denying the Motion to Dismiss or in the Alternative Motion for Summary Judgment.
